Animal Application

Policy Guidelines

- Permission to keep an animal is granted at management's sole discretion and is subject to resident's strict adherence to all aspects of the animal agreement.
- All animal owners must complete an Animal Application, have the animal approved by the Owner/Agent, and sign the appropriate animal agreement before the animal may occupy the unit.
- Any additional animals or changing of animals will require a new agreement.
- All dogs and cats must be a least 1 year of age, animals younger than 1 year may be approved on a case-by-case basis.
- Only common household pets will be allowed. These include dogs, cats, fish, birds, and rodents such as Guinea Pigs & Hamsters. Any other species may be approved only at management's discretion. No tenants will be allowed to keep more than one animal at a time. Requests to keep more than one animal may be approved only at management's discretion.
- Animals that are not allowed include but are not limited to; Ferrets, Prairie Dogs, Primates, Hawking Birds, Poisonous Reptiles, Snakes, Iguanas, Insects and Arachnids. Livestock animals are prohibited by the city of La Grande, which includes Rabbits & Chickens.
- No animal with a history of aggressive, threatening, or violent behavior will be allowed. At Owner/Agents discretion, breeds with a disposition for aggressive behavior may be prohibited.
- Dog breeds not allowed include but are not limited to; Pit Bulls, Chow Chows, German Shepherds, Siberian Huskies, Alaskan Malamutes, Doberman Pinschers, Great Danes, Wolf-Hybrids, Rottweilers, Rhodesian Ridgebacks, Boxers, Presa Canarios, Bulldogs, and any dog with an adult weight of 50 lbs. or greater.
- In making a decision on whether to approve a tenant's request to keep a dog, management will take into account the dog's temperament and whether or not the tenant has made arrangements for training/exercising the dog.
- All dogs and cats over 6 months of age MUST be spayed or neutered, unless a veterinarian certifies that health problems prevent the dog or cat from being spayed or neutered.
- All animals must be properly licensed and have shots required by statute or regulations at all times.
- Before move-in of animal, tenant shall provide Owner/Agent with proof of insurance of a minimum of \$100,000.00 liability coverage to cover any damage or injury caused by said animal. Owner/Agent must be named as an additional insured on the tenant's insurance policy if possible. Said proof shall be subject to re-verification at any time a declaration page is reissued. The company or agent must be instructed to notify the Owner/Agent of any lapse of insurance coverage if possible.
- Dogs and cats must wear identification tags at all times.
- Management reserves the right to amend any and all provisions/guidelines at any time.
